VALUE ADDED TAX ACT, No. 14 OF 2002 AS AMENDED BY ACT, No. 06 OF 2005

Order under Section 2A

BY virtue of the powers vested in me by Section 2A of the Value Added Tax Act, No. 14 of 2002, as amended by Act, No. 06 of 2005, I, Mahinda Rajapaksa, Minister of Finance and Economic Affairs, do by this Order declare that the Value Added Tax shall be charged on the importation or supply of imported goods specified under H. S. Code and description in Column I and II of the Schedule hereto, at the rate specified in the corresponding entry in Column III, of such Schedule.

The Order made under Section 2A of the Value Added Tax Act, No. 14 of 2002 and published in the *Extraordinary Gazette Notification*, No. 2089/13 dated 17.09.2018 is hereby rescinded.
