


**Government Notification**

**SRI LANKA EXPORT DEVELOPMENT ACT, No. 40 of 1979**

**Order under Section 14**

BY virtue of the powers vested in me by Section 14(2) of the Sri Lanka Export Development Act, No. 40 of 1979, I, Malik Samarawickrama, Minister of Development Strategies and International Trade, with the concurrence of the Minister of Finance, do by this Order rescind the amount of CESS specified in the corresponding entry in Column IV in the Schedule to the Extraordinary Gazette No. 2047/2 dated November 27, 2017, in respect of the article specified in the Schedule hereto, with effect from March, 2019.
